Salt Lake City Police Department

Detective Pedersen (801-799-3625 or CIUDistrict5@slcgov.com) – Burglaries are very difficult to solve due to a lack of suspect information. Sixty-eight officers from the detective division executed a community outreach effort and visited 2874 homes. They either spoke directly to the residents or they left behind tip cards with information on protecting against burglaries, car theft, etc.

The department is also conducting bait bicycle operations and package theft operations to catch suspects in the act.

Main Program Items

Salt Lake Police Department dispatch system update

- Jennifer Seeling followed up on the dispatch system issues raised at November's meeting.
- Dispatch is a separate entity from the police and fire departments. Dispatch customers include both internal customers (police and fire) and external customers (general public).
- The mayor's office met with dispatch immediately following the November community council meeting to discuss concerns.



- Current policy is that, if a caller does not have any suspect information, the preferred reporting method is to file a report online.
- However, the dispatch script has been updated to state that if a caller needs a police officer, one will come.
- The administration also plans to assess customer service for both internal and external dispatch customers.
- If you call dispatch and are denied the opportunity to file a report over the phone, hang up, call back and ask for a supervisor.

Pilot Volunteer Program

- At the last meeting, several residents expressed interest in volunteering to address issues of homelessness and safety in the community.
- The Mayor's Office invited Deeda Seed to discuss what a community outreach pilot project might look like in the area.
- Deeda suggested the possibility of a four-month program to assess what's happening with homeless individuals in the Liberty Wells community. The assessment could then shape concrete actions for addressing the issues.
- The community council asked Deeda to come back to the next meeting with specific program proposals.
- LWCC is willing to coordinate with residents in the community to gather volunteers as appropriate.

City Council District 5 update

- City Council held their final session of 2017.
- The council approved funding to purchase the Capitol Motel as part of the State Street redevelopment project area. The Housing Authority will develop and hold the property for mixed rate housing, i.e. a combination of affordable and market rate housing.
- The council also voted to fund 50 new police officers and to approve Salt Lake City's long-term housing plan.
- Going into the new year, Councilmember Mendenhall will continue to push for a human trafficking needs assessment. The city knows human trafficking is an issue, but not much is known about the victims specifically.

- After the council voted to approve the city housing plan, Mayor Biskupski issued several executive memos instructing city officials to write rules that require the evaluation of sellable surplus city land for housing development.
