Salt Lake City Fire Department, Station 8

Salt Lake City Police Department

- SLCPD had received several reports of a white Crown Victoria prowling neighborhoods. On Jan. 26, the police impounded the car and brought the suspects in on six illicit drug charges.
- SLCPD has also followed up on complaints related to the Georgia Apartments on 2100 S and 200 E. They have issued citations to individuals sleeping in the burned-out units, as well as a “no trespassing” affidavit. The landlord is currently working with the fire department to fix code issues.
- Areas with high complaints of activities like car prowling have been added to the system for officers to patrol when they are not responding to calls.

Main Program Items

Capitol Motel Project

- In January, the Salt Lake City Council approved \$3.2 million for Housing Assistance Management Enterprise (HAME) to purchase and develop four parcels on the 1700 South block of State Street.
- These lots include the Capitol Motel and two other businesses. HAME, in collaboration with the Housing Authority of Salt Lake City, hopes to build a four-story, mixed-use project with 108 units.
- HAME closed on the properties on Jan. 18, and they immediately began making improvements to the Capitol Motel area. For example, much of the motel has been repainted, lighting has been updated, fencing has been installed, and security guards are on premises 24 hours a day. Many of the previous occupants moved out, but nine rooms are still occupied.
- HAME will operate the motel during the transition period. HAME hopes to begin demolishing in one year and building in two years.
- The project is currently waiting on the approval of tax credits in order to move forward with next steps. HAME will continue to update the community council as the project moves forward.

Liberty Wells Homeless Neighbor Pilot Project follow-up

- Liberty Wells residents expressed concern about the impact of the homeless in their neighborhoods and in Liberty Park.
- The Salt Lake City mayor's office proposed a community pilot project, conducted under the auspices of volunteers in the community.
- This goal of this project is to gather data and provide suggestions and solutions to help improve the day-to-day experiences regarding Liberty Wells community members and the homeless community.
- The mayor's office, in conjunction with community council volunteers, issued an online survey to the community. As of Feb. 13, 270 people responded to the survey. Survey results will be reported at a future community council meeting.

- The Utah State Legislature began the 2018 General Session on Jan. 22. The mayor's office put forward specific legislative priorities related to affordable housing and homelessness, air quality and renewable energy, transportation, water and local development projects. - Mayor Biskupski and the city council are also exploring two funding options to address growth issues related to housing, transit, public safety, infrastructure and air quality.
 - One option would increase the local sales tax by one-half percent, generating an estimated \$35 million each year
 - Another option would be to bond up \$87 million to generate one-time revenue for replacing aging streets and sidewalks
- Arts for All is officially underway. The program is a city-county initiative offering an average of 25 tickets for individual Eccles Theater events through a random drawing. To be eligible to enter the drawing for tickets, city and county residents must receive SNAP benefits or be eligible for free or reduced lunches.
