- The International Association of Chiefs of Police is coming to Salt Lake City to conduct a survey about staffing needs at the Salt Lake City Police Department. This includes a public comment session at the Public Safety Building (475 S 300 E) on April 17 at 6:30 pm. Be sure to attend and provide input.
- Civil violations are outside the jurisdiction of the police department. When the police department gets calls about civil violations, they contact Salt Lake City Civil Enforcement.
- Det. Pedersen invited Carol Gent of Civil Enforcement to talk about her department. Carol is part of the multijurisdictional Community Action Team working with the police department and other agencies on various issues throughout the city.
- Civil Enforcement handles zoning complaints on private property, weed enforcement, snow enforcement, housing enforcement on rental properties, and other property and zoning violations.
- Civil Enforcement is not allowed to self-generate work, with the exception of weeds enforcement.
- Complaints are always anonymous, but contact information is very helpful for case follow-up.
- If you see an issue, call 801-535-7225. You may also submit issues or concerns through the Salt Lake City CitySourced app. Search for “City Sourced SLC Mobile” or “SLC Mobile” in your iOS or Android app store to download.

### *Call 2 Haul Bulk Waste Collection overview*

- Sophia Nicholas, SLC Sustainability Department, 801-535-7755
- The city collected public input on their bulky waste neighborhood cleanup program, gathering nearly 4,100 responses – a record for city surveys
- The main takeaway: move away from piles on street.
  - Issues with storm water regulation – storm water isn't treated, it goes directly into rivers, creeks and lakes. Organic material is one of the biggest problems. As organic matter decays, it draws oxygen out of the water.
  - Other items in those piles that cause pollution concern.
  - The program facilitated illegal dumping, especially on the west side.
- The new Call2Haul program begins July 1 and will operate year-round.
- It emphasizes containerization of materials, rather than piles.
- Each household may request one bulky waste pickup per year, at any time of year.
- Phase One will support call-in requests. When you call, be prepared to answer a short series of questions about the items to be picked up.
- Trees and limbs that are more than 6" in diameter can be put out in the curb.
- The city will provide two additional green waste containers for smaller items.

### **Public Lands Maintenance Priorities**

- In 2017, Salt Lake City Public Lands conducted an asset evaluation for all public parks within the city. The evaluation graded all park assets (benches, playgrounds, fields, etc.) and natural land areas.
- Based on this information, Public Lands identified and prioritized needs within the city's park trail and natural lands areas according to city council districts.
- It's important to note that these are future hopes or plans—these projects are not necessarily funded.
- Liberty Wells Community Council is the sponsoring constituent of the Seven Canyons Fountain project. We requested an initial \$60,000 to study what would need to be done to bring the fountain into code compliance.

- Linda discussed two volunteer opportunities for older adults who would like to get involved in the community:
- The “foster grandparent” program connects seniors with tutoring opportunities in neighborhood schools. This program reaches 5,000 – 6,000 children each year.
- The “senior companion” program connects seniors with other older adults who are homebound. Senior companions might help with errands, go for walks to the park, or help their companions to the senior center, etc. The senior companion program serve 287 clients a year who would otherwise be in a nursing home.
- These volunteer opportunities are open to anyone over age 55.
